For students and/or parents who filed a 2023 Federal Tax Return:

Federal Tax Information (FTI). Check your MaineStreet "To Do" list for requested documentation. If tax documentation is requested, you can provide one of the following:

A: Federal Tax Return. Provide a **SIGNED** copy of the 2023 Federal Tax Return IRS Form 1040 (Pages 1 and 2) with Schedules 1, 2 and 3 (if filed). Clearly print your name and student ID number at the top of the page before submitting the document to USM.

B: IRS Tax Return Transcript. Go to www.IRS.gov, select "Get Your Tax Record" link, or call 1-800-908-9946 to request a 2023 IRS Tax Return Transcript. Make sure to request the 2023 IRS Tax "Return" Transcript (NOT the IRS Tax "Account" Transcript). Clearly print your name and student ID number at the top of the page before submitting the document to USM.

Important Notes:

- If you or your parent(s) filed, or will file, an <u>amended 2023 federal tax return</u>, have been the <u>victim of IRS</u> <u>identity theft</u> in 2023, filed a <u>foreign tax return</u>, or have been <u>granted an extension</u> beyond the automatic sixmonth extension for tax year 2023, you must contact the Student Financial Services Office for specific instructions.
- If two parents were reported in Section B of the verification worksheet, the instructions refer and apply to both parents. If the parents had a <u>change in marital status</u> after December 31, 2023, please contact the Student Financial Services Office.

For students and/or parents who did not and were not required to file a 2023 Federal Tax Return:

Dependent students who did not file a 2023 federal tax return and had earned income from work:

In section C list every employer and the amounts earned in 2023, even if the employer did not issue you a 2023 W-2. You must attach a copy of the W-2 for each employer that was required to provide a W-2. If you no longer have the W-2, request a copy from the employer. If more space is needed, attach a separate page with the student's name and ID Number at the top.

Parents of dependent students who did not file a 2023 federal tax return:

If parents earned income in 2023, in section D list every employer and the amounts earned in 2023, even if the employer did not issue you a 2023 W-2. You must attach a copy of the W-2 for each employer that was required to provide a W-2. If you no longer have the W-2, request a copy from the employer. If more space is needed, attach a separate page with the student's name and ID number at the top.
